We also applaud your announcement that bicameral committee leadership will begin a process to consider reform of the Communications Act to better fit today's communications marketplace. We appreciate your leadership to ensure that Congress can provide longer-term stability for all stakeholders in this space. We see these parallel legislative and regulatory processes as perfectly consistent to deal with both the short term needs and the long term reform of broadband policy. As the FCC does necessary work to fill the gap in consumer protection created by the court decision, we look forward to working with you in a legislative process that will protect consumers and promote innovation and economic growth.

The undersigned organizations commit to working with you in the long process to consider the best path for a comprehensive revision of communications law. We would like to make sure the voices of average consumers and citizens are not lost in this process. We hope you will see fit to involve consumer and public interest voices in the same discussions alongside industry leaders and other stakeholders as you move forward to reform the Communications Act and establish long-term consumer safeguards, while promoting greater access, competition, innovation and economic growth. We support your call for a rational approach to this important task and look forward to working with you in the months ahead.
